DBA insurance is different from Workmen's Compensation Plan (WCP) and DBA insurance premium charges will be reimbursed by the U.S. Government. Offerors shall estimate the cost of DBA premium after contacting the authorized insurance provider. Once the contract is awarded, you shall reach out to the insurance provider and pay the premium. The receipt and insurance policy shall then be forwarded to the Embassy for reimbursement. Offers will not be accepted without DBA insurance costs.

Proposals are due by December 21, 2018 at 11:30 local time.

SECTION B

-SUPPLIES OR SERVICES AND PRICES/COSTS

B.1 SCOPE OF SERVICES

The purpose of this fixed price contract is to obtain the services **LABOR ONLY** of a handyman in charge of routine maintenance services on the electrical, air conditioning, plumbing and general repairs at the real properties leased by the U.S. Government in Douala (EBO Office and Residence respectively), Cameroon. **The U.S. Embassy shall provide all replacement parts.** The Contractor shall perform routine maintenance services in all designated spaces including, but not limited to halls, offices, restrooms, work areas, entranceways, lobbies, storage areas, and stairways. The contract will be for a one-year period from the date of the contract award, with a single one-year option. The contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

TYPES OF SERVICES

Standard Services shall include the following:

Routine Maintenance – Electrical installations

- Weekly verification of electrical circuits and breakers and replacement of damaged breakers as needed
- Bi-monthly routine check on the cable lines to ensure safety and security of all installations
- Weekly routine check and replacement of lamps and outlets as needed
- Quarterly verification of fire extinguishers and replacement
- Monthly routine verification of electrical fuses and replacement of damaged ones as needed
- Monthly preventive maintenance and servicing on the entire electrical network on EBO occupied space
- Provide expert technical advice as needed on how to improve or better secure the electrical installations at the EBO leased space
- Immediate , response within 5 hours for emergency maintenance needs and on call assistance 24 hours a day, 7 days a week
- Provide contact information for the technician who will be performing the job as well as the one who will be called for emergency services if different

Routine Maintenance – Air Conditioning (AC) Units

- Conduct servicing of 21 AC units at split level in the EBO Office and Residence

- Thorough monthly maintenance of the status of each AC Unit
- Monthly preventive maintenance by cleaning, refilling of gas and minor repairs
- Ensure proper drainage system for all AC water collection pipes and repair any clogging
- Submit all requests for replacement parts to be purchased to the COR
- Immediate response with 5 hours to emergency maintenance needs on call assistance 24 hours a day, 7 days a week
- Provide contact information for the technician who will be performing the job as well as the one who will be called for emergency services if different

-On Call Maintenance on the restrooms.

- Conduct a regular check on the plumbing installations for breakdowns and leakages
- Periodic (bi-annual) check on the flushing system for preventive repairs including changing of toilet mechanism
- Periodic (bi-annual) unclogging of drainage and waste pipes as needed
- Quarterly treatment of the waste pit to fight against bad odors
- Repair and/or replacement of broken parts in plumbing system in the kitchen
- Submit all requests for parts to be purchased to the Assistant Director for Operations
- Provide contact information for the technician who will be performing the job as well as the one who will be called for emergency services if different
- Immediate response within 4 hours to emergency maintenance needs on call assistance 24 hours a day, 7 days a week

Provide all Routine General Maintenance and repairs including but not limited to: carpentry, masonry, painting, electricity, HVAC, plumbing

- Repair and/or replace door locks as needed
- Repair damages on the current office furniture and assist in the installation and routine maintenance of newly acquired office furniture
- Install office decoration gadgets such as flags, posters, pictures and name tags
- Patch water leakage on any spot affecting the EBO office space
- Conduct a thorough assessment of the cause for bad odor at some spots within the EBO office and provide lasting solution to this problem

B.2 TYPE OF CONTRACT

This is a fixed price type contract for scheduled maintenance services as defined in the Comprehensive Maintenance Plan (CMP) The fixed price will include all work, including furnishing all labor, tools, equipment and services, overhead (including cost of Workers' Compensation and War-Hazard Insurance, which shall not be a direct reimbursement) and profit, unless otherwise specified

B.3 PRICES/COSTS

B.3.1 Value Added Tax

VALUE ADDED TAX (VAT). The Contractor shall include VAT as a separate charge on the Invoice and as a separate line item in Section B.

B.3.2 All prices shall be submitted in *FCFA*

B.3.3 Scheduled Maintenance Services

(a) In consideration of satisfactory performance of all the scheduled services required under this contract, the Contractor shall be paid a fixed-price per month for Scheduled Maintenance Services. No additional sums will be payable on account of any escalation in the cost of labor (unless mandated by local law see B.7),

(b) Premium pay for services required to be provided on holidays is included only in the fixed prices for Scheduled Maintenance Services.

“Inverted domestic corporation”, means a foreign incorporated entity that meets the definition of an inverted domestic corporation under [6 U.S.C. 395\(b\)](#), applied in accordance with the rules and definitions of [6 U.S.C. 395\(c\)](#).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). ADDENDUM TO REPRESENTATIONS AND CERTIFICATIONS

The following DOSAR provision is provided in full text:

652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
